

Family Feud Great Cash Giveaway

1. How to Enter the Contest:

(a) The Family Feud Great Cash Giveaway Contest will begin April 16, 2018 at 7pm and end on April 20th, 2018 at 9pm. Contest is sponsored by Atlanta's CW69 and Family Feud.

(b) To participate in the contest, contestants may enter in either of two ways:

1) Watch "Family Feud" on the CW69 between 7 and 8pm on any weeknight between April 16, 2018 and April 20th, 2018 to get a code word, then text the code word from your mobile device to the advertised short code and you will automatically be entered into the contest. You have until 9pm each night to enter the contest.

Or

2) Watch "Family Feud" on the CW69 between 7 and 8pm on any weeknight between April 16, 2018 and April 20th, 2018 to get a code word, then go to <http://atlcw.tv> and follow the links to the contest page. Enter the code word and other contact information in the form and you will be entered into the contest. You have until 9pm each night to enter the contest.

Contestants must either use a mobile phone (text entry) or provide a valid mobile phone number (web entry) in order to enter the contest.

Text messaging method of entry requires 2-way text messaging capable phone and digital service. Text messaging is not available in all areas in the U.S. Sponsors are not responsible for telephone service outages, delays, equipment malfunctions, errors or data loss of any kind, lost or unavailable connections, or failed, incomplete or deleted transmissions or other technological difficulties that may prevent an individual from completing his/her text. Contestants will receive a bounce back message confirming their contest entry

If the judges determine, in their sole discretion, that there is any suspected or actual electronic tampering with the Contest or if technical difficulties compromise the integrity of the Contest, the judges reserve the right to void the entries at issue and/or terminate the Contest and conduct a random drawing to award the prize among all eligible entries received as of the termination date. If the Contest is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at www.atlcw.tv. If, for any reason, the Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical

failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest. Sponsor reserves the right to disqualify any entrant that tampers with the operation of the Contest or website or violates the Official Rules of the Contest.

- (e) Broadcasts are subject to preemptions and scheduling changes. If such changes occur they will be posted on Atlanta's CW69 website.
- (f) Entry deemed made by holder of e-mail account or mobile phone account.

2. Eligibility Restrictions:

- (a) The contest is open to state of Georgia residents who are 18 years of age or older. Employees of WUPA-TV, CBS Corporation, other television and radio stations in the Atlanta market, and their affiliates, subsidiaries and advertising agencies and their immediate family members and persons living in the same household are ineligible to participate or win.
- (b) Viewers are eligible to win a WUPA-TV contest only once every sixty days. Only one winner per household is permitted in any contest. Viewers are eligible to win a prize valued at \$600.00 or more only once every six months.
